Tuolumne County Behavioral Health Department is required to hold a 30-day public review and comment period in order to draw down the remaining MHSA CTFN funds of \$372, 047 from the MHSA Component Planning Estimate. This review period begins May 16th, 2011 and ends June 15th, 2011.
